Overview of Water Infrastructure Funding

Major Water Funding Sources

State Grant Programs

State agencies have a wide variety of available water funding programs.

Previously Existing Federal Programs

Many federal programs have existed for years, subject to annual appropriation.

Bipartisan Infrastructure Law

Expanded previously existing programs and created new programs.

Inflation Reduction Act

Expanded previously existing programs and created new programs

State Grant Programs

- Subject to annual appropriation and/or action of the CWCB, a wide variety of funding options exist in-state.
- Annually funded programs include:
 - Water Plan Grant Program
 - Water storage/supply, water sharing, conservation/land use planning, engagement/innovation, agricultural, watershed health, and recreation.
 - Water Supply Reserve Fund
 - Studies/analysis, design, infrastructure replacement

State Programs (continued)

- Annually funded programs include:
 - Wildfire Ready Watersheds
 - Public Education, Participation, and Outreach (PEPO)
 - Federal Technical Assistance Grants
 - Non-reimbursable Project Investment Grants

Water Project Loan Program

Previously Existing Federal Programs

- Subject to annual appropriation, many federal water funding programs have benefitted Colorado water users for years
- Annually funded programs include a wide array of purposes:
 - Water conservation
 - Agricultural water management
 - Water quality
 - Drought response
 - Flood mitigation



Bipartisan Infrastructure Law (BIL)

- The BIL was signed into law by President Biden on November 15, 2021, including over \$60 billion for water.
- Primarily provided infusions of funding to existing water programs, like the EPA's State Revolving Funds and USBR's WaterSMART program.
- The BIL also directed federal agencies to create new programs, including programs that address:
 - Watershed health
 - Aquatic ecosystem health
 - Water reuse and recycling
 - Lead service line replacement



Types of Funding Administration

- Federal water funding, including funding provided by the BIL, is administered by federal agencies in a wide variety of ways.
- The primary administration methods include:
 - Direct federal administration
 - Formula grants
 - Competitive grants

Inflation Reduction Act (IRA)

- Signed into law by President Biden on August 16, 2022
- The IRA contained over \$4 billion in water funding for western states, including:
 - Drought relief for tribes (\$12.5M)
 - Canal improvement projects (\$25M)
 - Domestic water supply projects (\$550M)
 - Drought mitigation (\$4B)

IRA Drought Mitigation

- \$4 billion was allocated to a new USBR Drought Mitigation fund
- The IRA provided broad authority to USBR to determine the process and focus of the investment, within three categories summarized below:
 - Compensation for voluntary reductions in consumptive use
 - Voluntary system conservation projects
 - Ecosystem and habitat restoration projects

IRA Drought Mitigation

- Of the \$4 billion total, USBR announced that \$500 million would be reserved for the Upper Basin States.
- Of the \$500 million reserved for Upper Basin States, up to \$125 million was set aside for implementation of the System Conservation Pilot Program, now entering its second year of implementation under IRA.
- The remaining \$375 million remains available to be allocated.

Tribal Resources and Considerations

Water Plan Grant Coordinators

- Four staff people have been added to the CWCB staff to conduct proactive grant outreach.
- The goal of these positions is to offer a customized but cohesive approach to communities across Colorado.
- Staff are located in four geographic regions across the state:

Federal Technical Assistance Grants for Colorado Water Projects

<u>Federal Technical Assistance Grants</u> will enable eligible entities to work with the Colorado Water Conservation Board (CWCB) contractors or to hire contractors to expand their capacity and expertise, in pursuit of federal funding opportunities that directly support the Colorado Water Plan objectives.

The allowable uses of this grant funding are broad in scope, to allow for the wide range of federal opportunities available.

Funding can be used for: preliminary project planning and design, preliminary permitting, development of estimated project costs, navigation of available federal opportunities, grant writing, and federal grant application submittal.

Eligible applicants include local governments, special districts, state agencies, non-profits, mutual ditch companies, and others. A minimum of 25% matching funds is required.


Currently, \$5M is available from the American Rescue Plan Act (ARPA). These funds are subject to all federal management requirements and must be contracted prior to Dec 30, 2024 and spent before Dec 30, 2026.

Tribal Considerations for Federal Grant Opportunities

- The majority of competitive federal water opportunities are available to tribes, while some are available only to tribes.
- For those opportunities that include tribes as an eligible applicant, special considerations often apply.
- Examples of special considerations that may apply include:
 - Waiver or modification of cost share requirements
 - Set-asides of competitive funding
 - Additional points applied to tribal applications during scoring of grant applications
 - Additional technical assistance options
- Colorado DNR and CWCB staff are willing and able to assist in navigating all aspects of federal grant opportunities, including tribal-specific considerations.

Water Funding Opportunity Navigator

- This database includes water funding opportunities available from federal and state agencies.
- Updated every month, this database shows currently open funding opportunities.
- Data includes descriptions, funds available, links to more information, contact information, match requirements, eligible entities, and time frames.

State Matching Fund Opportunities

SB22-215 (Infrastructure Investment and Jobs Act Cash Fund)

- This bill creates a fund to assist state agencies, local governments, and tribes with matching fund needs associated with the IIJA. Information for local governments can be found on the DOLA website.
- The bill provides \$80M for this fund for the following categories of projects:
 - Transportation infrastructure projects
 - Water, environmental, and resiliency projects
 - o Power, grid, and broadband projects
 - Any other infrastructure projects explicitly funded in the federal act

SB23-283 (Mechanisms for Federal Infrastructure Funding)

• This bill makes available another \$84M to support the types of infrastructure projects listed above, as well as projects funded by the Inflation Reduction Act.

Existing State Grant Programs

Funding from existing state grant programs is often encouraged to be braided with federal funding.
